

Yesterday I had a long talk with State Trooper Greg Worrell about the Wilson murder; he has a special personal interest in it as his son went to school with her son; he has related to me that he has personally had a lawsuit against NY(?) and officers lied against him; the state then settled and avoided the suit.

It explains why bisexual man Gary Erickson is involved and his friends, Beaumont; sexual revolution; free sex; very possible; it explains why Darek Banasik laments her loss (if it's her hje laments; but he does lament a loss of someone 'one heart beating alone'...)

Banasik was in Ontario in 1990, editing and directing a movie called Morning; about two mute women, something asbout government, and island?? which suggests remoteness, aloneness; unable to speak, explain; say what happened; I have not been able to locate thje movie, but found more on it nthios morning onlione.

I believe Banasik is related somehow to Meehan, infostreet; I believe meehan was with Telent Communications; see similarities to instantweb, using alphabetic format; Meehan may have been the man who left Jamestown the day after her disappearance; hmm, he could have paid for her 'disposal'.

Instantweb is a compilation of people lamenting injustice; Iranian female songwriter, Lauffenberger, Banasik, there are others; i believe the site owner personally knows Meehan; maybe from prison; Lauffenberger never denied my assertions of knowing them; especially the gary2ca website; he said nothing. I was most likely right about how that happened; that Lauffenberger went to California met w/ Meehan Meehan showed him how easy it was to make a webpage by making that quickly, like magic. Lauffenberger had to learn somewhere; maybe from Meehan.

There must be a connection, i think.

The other big thing is that Greg personally knew Earl Barnes; and was 'lucky' he had only known that name, as Barnes was later convicted soon afterward, for drugs, etc and he thinks homicide; he could have been killed if he had used Barnes' real name of Patrick something when Greg entered his home, to get furniture back for an older landlady whose furniture was stolen by Barnes.
