

Update on the Kathy Wilson investigation.

New review of facts supports a very disturbing viewpoint;  
That many in the investigation knew of involvement of murder for hire; a motorcycle gang, tractor trailer truck theft ring, drug traffickers, defense lawyers, Prosecutors, District Attorneys all had knowledge of the corrupt involvement and cover-up between all involved.

The police and lawyers knew of bikers giving Michael Reuben Brown a brand new \$8,000. Model 883 Harley Davidson Sportster; signifying a connection that was Brown being 'brought into' the gang to cover information and connections he knew of regarding Buckley , himself (Brown) and others involved in the murder of Kathy Wilson.

The biggest lie Brown made was the one he did not say; he committed silence as fraud wherein he had knowledge that Wilson was NOT murdered the same day as she disappeared; but was killed afterward; and was alive one week later; at the home (trailer) of a biker; a founder of the 'Brotherhood'.

Earl Barnes AKA Patrick Arnold was at that time in court or being investigated for drug trafficking and homicide; he later went to prison for two years for those crimes.

Brown knew of the involvement of the bikers and was 'paid' to remain silent; and present statements to implicate his one-time friend William Jay Buckley for the murder alone.

Brown was then brought in by PA police and DA and given false facts by them to say under oath and in statements to be used in court for the conviction of Buckley.

It appears the bikers did not approve of this and then destroyed the Harley they had given Brown;

Brown's parents MUST have known of their son's connection to the bikers; and payment to Brown by bikers;

The police are very much in tune with such 'gifts', looking for theft by suspects; if the obtaining of the Harley appeared legitimate, the police would have connected the gift with the givers; being the bikers.

To have overlooked the gift would have been absurd; investigators would not overlook that connection.

That knowledge would have been known to initial investigator Captain Manzi; Manzi later moved far away into another position; according to Harold Thomas Beck's books, 158 pages of the initial investigation disappeared and was destroyed.

If that is true; which is very much believable; then record of connections of bikers to lawyers, to a national truck theft ring would have also been destroyed and concealed.

Buckley was subpoenaed to testify in a case where trial was held in Missouri, regarding knowledge he had of theft of tractor-trailer trucks, their dismantling and sale; This was apparently occurring in Geary NY, at an associate of Buckley's; if Buckley testified, he must have been given protection from being included in the ring; yet no protection could be offered to Buckley by the government from actions against Buckley indirectly; by those he testified against; as they could- and did- work underground and behind the scenes to set Buckley up for the murder of Kathy Wilson.

I told FBI agent Joseph Wenger of the subpoena of Buckley; he denied that it was real, and said he would have known of it. In papers from the trial, the subpoena of Buckley to testify was stated, and a different FBI agent cited. It would be unthinkable that FBI agents would not communicate on such important matters.

Brown would not have been able to testify against Buckley, if Wilson's remains were found in NY; as NY Law prohibits co-defendants from testifying against each other. "Luckily", for those who wanted to use Brown against Buckley, Wilson's skeleton was found in Lander, PA, ten miles from the NY / PA border; allowing the bikers' new, young and impressionable 'friend', Brown to testify against Buckley- and set Buckley up as having committed the murder alone; as an act of rape and theft.

It should be noted that at a party, Brown told friends that Wilson's body would be found behind Central Tractor, which was located between Falconer and Jamestown. For her to have been found in PA, the corpse would have had to have been moved. However, that line of thought is not consistent with the theory of her being alive in Lander one week after disappearance; it is just worthy of note, in case those theories are found to be not true.

No money or credit cards were taken.

It appears the murder took place more than a week after her disappearance; Brown made the mistake of saying Buckley came out of the woods with a camera; Shelley Anderson testified saying she had taken Buckley to the Lander area after the disappearance of Wilson; None of those facts bade up to rape and theft; in fact they disprove the premise.

Sighting of Wilson in Lander at convicted murderer Patrick Arnold's property supports three other sightings in Lander at that time; those testimonies were systematically destroyed and removed by defense attorney Barry Smith, because of timing;

In fact; if Smith had wanted to destroy ability to claim his client had raped and murdered Wilson; he could have shown the sighting to have been acceptable as exhibits; therefore removing rape and theft as motive.

The natural change at trial would have then been murder for hire; especially in light of Brown's statement about a camera; and Anderson's taking Buckley to Lander;

Smith had to have known the murder was murder for hire. If his client Buckley was not guilty of it; Smith would have at least removed the motive stated by Prosecution;

It would appear that prosecution also had knowledge of the murder for hire; and, like Smith, wanted to avoid exposing others involved in the murder; especially the hiring and carrying-out portions.

The Police had to have known of Brown's connection to the bikers.

District Attorney would have also had that knowledge;  
The police reports regarding Brown's getting of the harley have remained in the record; apparently for a reason; to provide insight as to 1. the gifting of the motorcycle; 2. the crashing of the motorcycle- by a biker friend; who was also into motorcycles.

The record does not show that any investigation occurred, regarding the suspicious Harley.

Yet; knowledge of it must have been had; and transferred to the DA and all lawyers involved.

Therefore;  
All involved in the Wilson case knew the bikers were involved; had tried top cover-up; and influenced young Michael Brown's testimony.

Brown's lies were said to be 767 lies; yet, the biggest lie he told was the lie he did not say; that he knew the murder occurred a week later; and therefore the murder was murder for hire, not rape and theft.

Whether Buckley committed the murder or not, he was blamed for it;  
The trial the ensued and actions and stated beliefs by all parties in law enforcement and justice system all led to one single, unrelated murderer, who acted randomly. That was not the truth; the truth was to some degree known by all investigators; at least the ones who were depended on to relay their findings to the next in line; it would be absurd to suppose that lawyers in this case did not know of biker connection.

Connection of Buckley to his testimony against his friends in the truck theft ring was also clearly known; and would have been clearly understood;

The conclusion must be that a cover-up of huge proportions occurred; protection of contacts in the case occurred; truckers, bikers, lawyers and whoever hired the murder were involved.

The day of Kathy Wilson's disappearance was strikingly connected to the life of Buckley, though he did not have reason to know her; May 18<sup>th</sup> was the last day of his parole for a related crime and vehicular homicide; that in itself would suggest that if Buckley was setup- the plan began before that date; it was too perfect to pass up; that suggests a plan was in effect for setting Buckley up for a crime, as punishment for 'ratting' on his friends

to get himself off; the crime chosen was murder; and a murder was desired by someone at that exact same time; for the murder of Kathy Wilson, a mother of three.

I do not believe that any biker gang today would want the stigma of connection to a murder of a mother of three children. Harley Davidson corporation has gone to great lengths to change the image of bikers; to that of freedom and righteousness; sometimes in opposition to government and laws; but certainly NOT in connection to murdering mommies.

Earl Barnes may have been her murderer; or Buckley; or another; it appears Buckley was baited into the situation, perhaps for money, as he had none and lived in a woods;

It does not make sense that anyone would solicit Buckley to commit a murder where he would need to transport the person or body; as he had no vehicle, and had to borrow Brown's; yet, a setup makes sense; depending on when Brown received the Harley, Buckley would have had knowledge of that; and could have thought he would be rewarded too. If the Harley gift came AFTER the disappearance of Wilson, the connection was too strong to ignore, by police, everyone; perhaps that was why so many have said they all believe it was Buckley and Brown; those same people, with that knowledge of the Harley, would also have strong belief that the murder was not only for hire; but was also a setup- of a 'rat' by the underworld he betrayed.

The message to all with that knowledge was to realize the power of the underworld; and their positions within that power; the notion of fear of repercussions was too strong and too real to ignore; who would they go to with evidence and their beliefs? The very [people they knew were covering up the truth; and committing fraud themselves; in the very positions they are sworn to uphold and citizens they are to protect.

Government became one with corruption; and with the very criminals the government should have arrested and put into custody; to protect the people at large.

Greg Worrell has not accepted four calls from me now; Officers at the desk have told me that he does not have voicemail set up; this comes in response to my telling Greg that I have used a recording of his voice in documents I sent to the court; where he talked of the AKA of Arnold; and the possibility of Brunea having represented Arnold in a case.

I now believe Worrell knew of the Harley; I had mentioned it in passing once long ago; he responded as if he knew of it, and did not ask more about it. He knew of it; as it would seem all officers knew of it; as they would communicate with each other to protect each other; as that was very important knowledge to have; watch out for Brown; as he is connected to the bikers; who can operate in the night and disappear to another state and never be found again.

Bikers do not operate within the law; only outside the law.

Lawyers operate within and around the law as they are trained in its controls and its loopholes.

Each work together and depend on each other.

The danger to the public increases when underground is connected with law and law enforcement.

That appears to be the case here; and is the reason the case has never been solved.

Beck's house and restaurant was burned; Lauffenberger's home was burned (barn)). Two 'suicides' occurred that had relation to the case;

Beck may have written his second boom under threats to mislead people on who did it; he blamed an unknown and unnamed plumber, with actually two names; he implicated Wilson's boss and sales associate; those connections could easily be attempt to cover; his statements of her vagina and pelvis being found in the cold water creek bed were lies; to make the reader think they should remain hidden; as their pubic hairs would be evidence; and so they could be caught if they are further involved.

Lauffenberger, who has spent four years in prison unjustly, according to him, has stopped communicating with me, after I told him I was in contact with Trooper Worrell; I warned him against believing Brown; as he has gone to see Brown and communicated with him. I still believe he has connection to Darek Banasik; through the instantweb.com website people; he has not said that was or was not true.

There were others involved who fled as well; maybe through drug connections; either drug use or sex; there are no leads on that. Only connection to rapid and hasty exiting of several people upon Wilson's disappearance; the connection appears to be knowledge of what happened to er, whether they were involved o not.

It appears there is a great deal of hiding going on, even in the past few years. It may be that the only way it will ever be solved is after all involved have died. PA destroyed all exhibits in 2008; other places may exist where they may be intact; but most likely are disjointed.

If I attempt to expose the connections between bikers, lawyers, truck underground theft ring and police; the situation may be more than anyone is willing to protect me for; I am already attempting to expose connections within Supreme Court, Surrogate's Court, Code Enforcement and Local town and village corrupt collusion in our family's case; To expose the other connections may be 'on the mark' Yet may be the undoing of myself and my children, well into the future.

If- I expose ONLY the connection between Brunea, Wilson and Arnold; that could perhaps bring in outsiders to investigate; And I could then be removed from the spotlight and from blame in the outcome;

Unless someone inside were to know what information I provide;  
Showing my connection to the expose of the bad-boys; my own personal strength and  
ability to fight would mean nothing.

My only hope during this exposing is to bring in others- above- who will find what I  
found.

The decision I would have to make is what to say; who to tell; which is similar to  
situation Brown was in; and Buckley was in; over twenty years ago.

I have no choice but to continue with the exposing process; with both Brunea and  
Calabrese; as they have been indirect murderers of my father; and assassins of my name  
and income and inheritance; destruction of my children's belief in the government;  
destruction and loss of my projects; and if I do not follow through, loss of our home 151  
and 133 too.

In following up; the possibility of exposing Brunea, Calabrese, Newcomb and Eagan ,  
Silverberg, Katz, etc, etc CAN happen.

If I do NOT follow through; they will have control over me for the rest of my life; and  
affect adversely my reputation into eternity; where all will think of me as the crook they  
said I was.

I have no choice but to follow through- IMMEDIATELY.

If- I play my full hand now- it will show that I am calling them all crooks.  
If I show only part- use a king and keep three aces for later; it may work better.

I am working this through in my mind now.

It is for that reason, I believe; that I have waited to follow up with the next blows;  
As the next blows to deliver must be on target and strong.

Maybe the last blows will be the ones needed to bring down the giant.

I CANNOT do it alone;

Reinforcements must come;

Believing they can solve the case; on their own;

Then when they begin, the rest will open the can of worms;

In that can will be Brunea; and Calabrese; Newcomb, and all.

I will withhold the biker / truck theft ring / police / lawyer connections;

It will be enough to show connection between Brunea and Arnold.

That will open Pandora's box.
